Section 1: Product Identification

- **Product Name:** Iso Propyl Propionate
- **Chemical Formula:** C₆H₁₂O₂
- **CAS No:** 637-78-5
- **Synonyms:** Propanoic acid, isopropyl ester
- **Recommended Use** Used as a solvent and fragrance ingredient; also in coatings and adhesives.

- **Concentration:** >95%

Section 4: First Aid Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid inhalation and skin/eye contact. Ensure adequate ventilation.

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use in well-ventilated areas.
- **Storage:** Store in tightly closed containers in a cool, dry, well-ventilated place. Protect from heat and light.
