Section 1: Product Identification

- **Product Name:** 4-Methylphenethyl Alcohol
- **Chemical Formula:** C₉H₁₂O
- **CAS No:** 699-02-5
- **Synonyms:** 4-Methyl-2-phenylethanol; p-Methylphenethyl alcohol
- **Recommended Use** Used as a fragrance ingredient in perfumery, cosmetics, and as a flavoring agent.

Section 2: Hazards Identification

- **Classification (GHS):** Skin Irritant, Eye Irritant.
- **Signal Word:** Warning
- **Hazard Statements:**
 - Causes skin irritation
 - Causes eye irritation

- **Precautionary Statements:**

- Avoid contact with skin and eyes
- Wear protective gloves and eye protection
- Wash hands thoroughly after handling

Section 3: Composition / Information on Ingredients

- **Concentration:** >95%

Section 4: First Aid Measures

- **Inhalation:** Move to fresh air. If symptoms occur, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Seek medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek immediate medical advice.

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
