Section 1: Product Identification

- **Product Name:** Anisyl Acetate
- **Chemical Formula:** $C_{10}H_{12}O_3$
- **CAS No:** 104-21-2
- **Synonyms:** 4-Methoxybenzyl acetate
- **Recommended Use** Used as an intermediate in organic synthesis and as a fragrance and flavoring ingredient with sweet, anisic odor notes.
